1 Having considered the Direct Purchaser Class Plaintiffs' Motion to Disburse BMS Settlement
2 Funds for BMS Settlement Administration Expenses, filed by KPH Healthcare Services, Inc. a/k/a
3 Kinney Drugs, Inc., on behalf of itself and the BMS DPP Settlement Class, the Court GRANTS the
